Rome, 31 May 2023 - Digital Value S.p.A. (DGV Ticker), a leading operator in Italy in the ICT infrastructure sector and a Euronext Tech Leaders company, announces that a well-known public body has granted the effective final adjudication of a Strategic Contract for Cloud Oracle SaaS-PaaS Services and specialist support, with a value of approximately €8 million, to its subsidiary Italware, in RT with the company Eurolink.

With a duration of 36 months, renewable for a further 12 months, the agreement aims to promote the modernisation of infrastructures and, as a priority, the migration to the Cloud of the back office applications of the entity's Instrumental Area, currently operating on an on-premise Oracle platform.

For the client this contract represents one of the most important steps in support of the "Journey to Cloud" strategy, promoted as part of the "Three-year Plan for IT in the Public Administration".
